## - Your Privacy Rights

**This Privacy Policy applies to the sites and apps where it appears.**

**We collect information from and about you.**

**We use information as otherwise permitted by law.**

**We will share information with third parties who perform services on our behalf.** For example, we share information with vendors who fulfill your purchases.

**We will share information with our business partners.** This includes a third party who provides or sponsors an event. **We may share information if we think we have to in order to comply with the law or to protect ourselves.** For example, we will share information to respond to a court order or subpoena. We may also share it if a government agency or investigatory body requests. Or, we might also share information when we are investigating potential fraud. This might include fraud we think has happened during a sweepstakes or promotion.

**This site and any affiliated apps are not intended for children.**

Our sites and any affiliated apps are meant for adults. We do not knowingly collect personally identifiable information from children under 13. If you are a parent or legal guardian and think your child under 13 has given us information, you can email us . You can also write to us at the address listed at the end of this policy.
